



RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

and residential address [_____],

hereby declare the following:

1. I am voluntarily participating in firearm training or other shooting activities (“Training”) provided and instructed by Mr. Alessandro De Grandis (the “Trainer”). I understand the risks, dangers and hazards involved, and I recognise that personal injury, death, permanent disability, property damage and other related harm (together “Harm”) can occur while carrying or using a firearm, participating in the Training, or later from the materials and skills presented during and as part of the Training.
2. I further understand that Harm may result from my use of, or proximity to, dangerous equipment or property (whether or not defective) owned, maintained, or controlled by the Trainer or by the False Bay Shooting Club, their agents, facilities owners, officers, directors, shareholders, employees, instructors, volunteers and other representatives (the “Indemnitees”).
3. In acknowledgment of the above and in consideration of being permitted to participate in the Training, I hereby agree as follows:
 - a) I accept and assume all such risks, dangers and hazards, whether now or in the future.
 - b) I knowingly, voluntarily, and expressly waive, release and discharge the Indemnitees from any and all liability for losses of whatsoever nature that I may sustain as a result of my participation in the Training, or by my direct or indirect use of the facilities, equipment, property or instruction made available to me during or as a result of the Training.
 - c) I agree to indemnify, keep indemnified, and hold harmless the Indemnitees against all losses, damages, claims, awards, costs, including reasonable legal costs (“Losses”), incurred by me, my heirs, executors, administrators or any other person so associated with me as a result of any Harm suffered by me as a result of my participation in the Training and other associated activities, whether or not caused by the negligence of the Indemnitees.
 - d) I further agree to indemnify, keep indemnified, and hold harmless the Indemnitees against all Losses incurred by any other person, whether or not associated with me, or to any property, as a result of Harm suffered by such person or to such property during or at any time after my participation in the Training and caused by my wilful or negligent actions or omissions, whether direct or indirect, including but not limited to my carrying or use of a firearm.
 - e) I acknowledge that the Indemnitees will not be released from liability in respect of their fraud, wilful misconduct or to the extent that such release of liability is not permitted by the laws of South Africa or the bodies governing the ownership and use of firearms.

- f) I warrant that I am physically fit and that I have no medical, psychological, or any other condition that would prevent my full and safe participation in the Training.
- g) I warrant that I have read and understood the contents of this document and that I have the necessary capacity and competence to agree to the warranties, representations and indemnities contained herein.
- h) I warrant that I will not knowingly bring, or use, any illegal or unsafe firearm to or on the Training premises or as part of the Training or during any activities provided or facilitated by the Trainer or any other Indemnitee.
- i) I warrant that I hold the necessary licenses and/or permits required to lawfully own or operate a firearm (where applicable).
- j) I agree to abide by all written, video, and verbal safety rules issued by the Trainer, Range Safety Officers, or the False Bay Sport Shooting Club administrators and staff (the "Responsible Persons").
- k) I agree that if one or more of the Responsible Persons reasonably believe that I am dangerous and pose any risk to myself or to any other person, or that I am or will become involved in criminal activity of any nature, the Trainer reserves the right to expel me from the Training with no refund and, if necessary and reasonable in the circumstances, to report me to Law Enforcement authorities. I agree not to hold the Responsible persons liable for defamation and/or libel as a result of their lawful exercise of the rights contained in this clause.
- l) I understand that I must sign this release of liability and fully comprehend the structure and nature of the Training, and also the risks involved before being allowed to participate in the Training.
- m) I confirm that all information provided by me to the Trainer, the Indemnitees and/or the Responsible Persons is complete and accurate in all respects.

I have read the above release and waiver of liability and fully understand its contents. I have been informed of the risks involved, and I voluntarily agree to the terms and conditions stated above.
